- Financial assistance with deposit, rent, transportation, utilities, and other short term assistance

Eligibility requirements: Dishonorable discharge and/or member of the guard or reserve with no active duty and/or over income for SSVF.

Veterans with Severe Mental Illness (VSMI) Shelter Program

- 60 day shelter
- Intensive case management
- Therapeutic services
- Employment services
- Housing Specialist support with securing housing
- 3 meals per day
- Group activities and workshops
- Access to all service center resources

Eligibility requirements: Must be a veteran of the United States Navy, Marine Corps, Army or Air Force with a discharge other than dishonorable. Must have mental and/or substance use illness.

Veterans Enhanced Shelter Program (VESP)

- 60 day shelter
- Intensive case management
- One-on-one employment assistance
- Housing Specialist support with securing housing
- 3 meals per day
- Transportation assistance
- Access to all service center resources and workshops

*HomeFirst also offers 60 day emergency shelter for homeless male veterans with 290 registration requirements.

Eligibility requirements: Program is available to male veterans who are eligible to receive medical care/ services through the Dept. of Veterans Affairs.
